I understand that registration and tuition is for a specific curriculum and for a specific term (as indicated on this form) and that it is not refundable or transferable to any other curriculum or any other term. I agree to pay this tuition (if I am accepted for enrollment and within ten days thereof declare my continued intention to study at SFD) in the manner indicated below.

September/January/June Applicants: Acceptance fee (upon notification thereof) \$3,600 tuition deposit (before July 1, November 1, or April 1 as applicable) \$3,600. Tuition balance (Before September 1, January 1, or June 1 as applicable) \$3,600. Note: Late applicants those who file on or after due date for the \$3,600 acceptance fee (May 1, October 1, or March 1 as applicable), or on or after the due dates for the \$3,600 tuition balance (September 1, January 1, or June 1 as applicable) are expected to prepay the amounts along with the required \$50 application fee at the time of filing. The tuition will be refunded only in the event that the applicant is denied acceptance, otherwise the prepaid tuition/fees will automatically be credited to the accepted applicant's tuition account.

Further, I understand that the amounts indicated above do not include the cost of school and class fees, books, kits, lab fees, fabrics and supplies, which vary according to the academic year as explained in the most recent school catalog, and which must be paid in full before September 1 (or January 1, June 1 as applicable).
